KNOTWEED POSTER

Possibility to post fliers around Illinois Valley area to encourage people to contact us about knotweed and to tell folks not to dig pull or cut it up.

ALYSSUM

County owns 70 acres under lease. Lease may soon be terminated and the Alyssum poses a threat of escape into adjacent sensitive botanical areas. Group decided to write to Commissioner offering to help with this problem through grant writing, organizing volunteers and technical assistance. At a minimum, we recommend that the area be harvested to avoid spread of seeds.

NURSERY LETTER

Robin reported that she contacted the state nursery inspector: Eric Rusche. He is willing to come give a presentation. We decided the following for the presentation:

- Evening to accommodate business owners
- Possible dates: May 8, or 13 or 20
- OSU extension preferred locale
- Invite other groups: Native plant society, Audubon, SWCD, Jackson CWMA folks and let them invite nurseries too
- Topics: weeds that come from landscape species or look alike, how to tell if cultivars are safe? What can we do to minimize escape from landscape plantings to noxious weed problems, other issues?

NOXIOUS WEED DAY

We did lots of planning—please see attached worksheet for details.

KNOTWEED POSTER

Kyle gave us a mocked poster. We liked it and made some suggestions to adjust the content to encourage them to contact us and not try to treat it themselves and make language more toward a basic level: i.e., "healthy happy native plants"

ALYSSUM

Effective treatment may require two years of spraying. Amy reported sending a message to Commissioner Toler about the group's interest in helping with grant-writing/control/eradication efforts. Group recommends that the seed source be dealt with this year by mowing/baling early. Also would recommend that the field be tilled under if possible and then treated chemically for at least two years.

It was noted that it is not listed as a noxious weed now. Can the CWMA make that suggestion?

Next Step: contact county again around April 15 to find out if they know what the plan is for the season.

NURSERY LETTER

Robin reported that she still needed to finalize the date for the Nursery presentation/workshop. We stuffed some envelopes with the other materials to be mailed and she will finalize the date and add it to the letter. Amy will help get a room.

NOXIOUS WEED DAY

Kyle shared the poster he designed and everyone liked it. He will email it out as a PDF and also as an active file if folks want to add anything to it.

- Robin wanted to get information ready and asked for help in the booth for the Master Gardener show April 26

- Amy will adapt the sponsor sheet in use by Jackson County for the Jo County event/group and mail it out ASAP
- Robin will email Doreen and Mary Bell to check in and see how they are progressing
- Robin got gloves from SOLV, but they were the wrong kind

ALYSSUM

No news about this except that we have been in contact with the Commissioners' office.

CWMA PROFILE

Amy shared a profile that was submitted in response to a request by ODA. It was noted that we need to update our list of important species. We did list in the profile, Alyssum on our list of high concern, even though it is not listed as an invasive due to the sensitive flora and endangered species in the area.

EARLY DETECTION RAPID RESPONSE TRAINING

Kyle explained the TNC is sponsoring another training for EDDR and would like to offer to target the Illinois Valley area. The area is unique in flora and has potential for some folks to come forward who might be really interested in watching for weeds. Kyle said co-sponsoring the event would not result in a lot of work. Basically we need to help recruit volunteers/participants and provide a list of 5-10 weeds we think are most critical to be watched out for in the area. We would also hope to identify sites where we could see these weeds. TNC probably has materials, but we might need to help with developing materials.

The group quickly listed Rush Skelton Weed, Knotweed, star thistle and leafy spurge as candidates. There was discussion as to whether or not we needed to field a response team to be able to respond to the weeds that might be identified by EDDR trainees. However, these folks will be reporting the sightings to the ODA hotline and or the landowner. In any case, there are agencies who would respond to public and private landowners. The CWMA could offer to help out on local response though.

NOXIOUS WEED DAY

WEED DAY DISCUSSION AND ANALYSIS

Everyone thought the weed day was a great success! We all felt that we could not have hoped for more. But being humans we couldn't help but think of a few things we could do better.

TO IMPROVE:

- Try to get on the city calendar
- Make presentations or announcements about the vent in person to key groups (not just send invites/emails)
- Identify event organizers better with name tags or hats or something
- Push daily courier harder and/or submit our own article to them after the event

Follow up items still pending/in progress:

- Mail thank yous to all sponsors (Kyle – Video World, Amy – Hellgate and Albertsons, Doreen - Parks Fndn and Dutch Bros, Brad – ODA and RBCC.
- Mail a thank you to participants
- Put participants' contact info in a spreadsheet for future contacts ease.

Amy reported that there was an invitation from the Jackson group to combine our event with the Jackson County event. Group discussed pros and cons without coming to any conclusion. Pros: shared advertising, shared workload for 'party' or volunteer appreciation. Cons: too far to go for celebration, possibility to lose some volunteers to other sites, loss of event identity.

WEED WATCHER TRAINING REPORT

the training went well although not as many participants as hoped. There were 9 people. It seemed that folks were busy with other events. They focused on 11 plants. Also noted that Spanish Broom was found on Draper Rd.

WEED PULL AT DEER CREEK CENTER

Close on the heels of the training, a weed pull was organized at Deer Creek Center to help out with start thistle and demonstrate one way that the center may want to deal with their weed issues. There were about 10 people.

There was an idea suggested to integrate weed info into some of the classes offered by Siskiyou Field Institute. And/or to develop a weed watcher program in conjunction with their class offerings

JACKSON COUNTY WEED WATCHER TRAINING

Kyle reminded everyone that there will be a training in the Jackson County area on July 26 at ODF&W. Christine will send the notice out to her Alpaca association list.

Garlic Mustard Festival. It was reported that back east some group had hosted a festival where they pulled and cooked the weed.

IV Knapweed project. Susan reported that they had submitted a request for funding to ODA for a Meadow Knapweed project to ODA. Having previously received a matching promise from National Forest Foundation they were hoping to get a modest sum from ODA. Unfortunately, the grant was turned down and the resulting funding is only \$640. The plan is to develop posters, mailings, provide training at the Dome School and develop a community based project. There has been some interest from local people to continue forward without funding. The group offered to try to lend support where possible as this project moves forward.

DECLARATION OF COOPERATION

Amy reported that the Declaration has been mailed out to folks we were targeting. Robin requested that we put City of Grants Pass on the list and Amy will find out exactly who to target for that mailing.

NURSERIES

We renewed discussion about involving nurseries and suggested that they might eventually be a place to try to get weed pamphlets and brochures displayed. It was also noted that personal contacts was probably the most effective contact method with nurseries (especially during the week, not weekends).

LEFTOVER TEE SHIRTS

The group decided to distribute the remaining tee shirts to groups who could give them to volunteers and use them for promotion. Also a few tees were handed out to sponsoring organizations. Tees were given to The Nature Conservancy, Forestry Action, ODA, RBCC, MRWC.
